

Things to Know for Submitting Program Year 2017 Meaningful Use Attestations

The Meaningful Use Administration Division of the Alabama Medicaid Agency would like to thank you for your participation in the Meaningful Use EHR Incentive Payment Program.

The Alabama State Level Registry (SLR) is scheduled to open Monday, December 18, 2017 at 8:00 a.m. CST to receive **ONLY** MU attestations for Program Year (PY) 2017 and the close date is March 31, 2018. However, before a provider can submit a 2017 attestation, their 2016 attestation process must be completed in the SLR. Therefore, if you are notified of any issues regarding your submitted PY 2016 attestation, please respond immediately to minimize any delays in processing your PY 2016 payment.

Required Documents for PY 2017:

The attached documents include detailed information for submitting your PY 2017 attestation. These documents include:

- **Security Risk Analysis Compliance Form** – *Each provider must complete a Security Risk Analysis. No exclusions are allowed.*
- **2017 Program Requirements – Protect Patient Health Information**
- **2017 Program Requirements – Eligible Professionals – Modified Stage 2**
- **2017 Program Requirements – Eligible Professionals – Stage 3**
- **2017 Program Requirements – Eligible Professionals – Modified Stage 2**
- **2017 Program Requirements – Eligible Professionals – Stage 3**
- **Required Documents** – A list of documents required for submitting your PY 2017 attestation
