The forum is a requirement by the Centers for Medicare & Medicaid Services (CMS) for the Section 1115 Demonstration Waiver under which the Plan First program operates. The waiver was originally approved in 2000, and it was renewed by CMS on November 27, 2017.

The current waiver will expire on September 30, 2024. Alabama Medicaid Plan First is seeking to renew this waiver.

The goal of the Plan First program is to reduce unintended pregnancies and improve the well-being of Alabama's children and families by extending Medicaid eligibility for family planning services to eligible women and men.

The comments will be summarized and addressed in the Annual Monitoring Report of the waiver to be submitted to CMS.
