



**The Alabama Medicaid Agency
Invites you to talk about proposed changes to
Medicaid Long Term Services and Supports**

The Alabama Medicaid Agency invites you to hear more about upcoming changes to Alabama's Long Term Supports and Services (LTSS) system. Last year, the legislature passed legislation creating Integrated Care Networks. AMA is seeking your input to inform the development of the ICN program. We would like to get your thoughts and ideas about long-term care, home and community based services and how service coordination can be improved for people who are older or disabled. We hope that you will join us for a meeting in your area.

In June, informational sessions were held to provide an overview of the program and its intended structure and goals. During this round of meetings, focus groups will be conducted, providing attendees a forum to share thoughts and feedback about the current state of LTSS, in an effort to help guide development of the ICN program.

Morning sessions: will be targeted to current Medicaid waiver participants, other LTSS consumers, their caregivers, their advocate, other interested parties, and are open to the public. These meetings will be focused on consumer specific topics.
