Pursuant to the requirements of the Home and Community-Based Settings Final Rule (Final Rule) regulations (CMS 2249- F/2296-F) issued by the Centers for Medicare and Medicaid Services (CMS) on March 17, 2014, the Alabama Medicaid Agency (AMA) is issuing this request for public review and comment. In brief, this opportunity for public comment is focused on the Final Rule requirements that Home and Community-Based Services (HCBS) are delivered in settings that are not institutional in nature.

## **Overview of this Request for Public Comment**

This public comment request addresses the State's identification of settings with characteristics that are presumed to be institutional in nature, but have overcome the presumption, or were expected to do so prior to the end of the transition period in March 2023. This information is intended to provide updates and corrections to the previous identification of such settings for the Intellectual Disabilities (ID) Waiver and the Living at Home Waiver (LAH) as posted on September 30, 2021 (Request for Public Comments for Home and Community-Based Complaint Settings, Settings Expected to Remediate and Settings Not Expected to Remediate) and again on February 28, 2022 (Request for Public Comments for Home and Community-Based Settings Final Rule STP).

At those times, the State reported a list of 741 ID and LAH settings (616 residential settings and 26 non-residential) settings that had, as of July 1, 2021, completed remediation that overcame the presumption that they were institutional in nature due to having isolating characteristics. The State also reported a list of 300 ID and LAH settings (251 residential settings and 49 non-residential settings) that had not yet completed remediation to overcome the presumption that they were institutional in nature due to having isolating characteristics; however, the State expected that all of these settings would achieve full remediation within the required timeframes.

After receiving public comment on these previous postings that questioned the accuracy of the reported remediation determinations, AMA worked with the Alabama Department of Mental Health, Division of Developmental Disabilities (ADMH-DDD), to undertake additional review processes. As a result, the State concluded that, overall, there was insufficient evidence of remediation to substantiate that any settings had overcome the presumption that they were institutional in nature. Therefore, the correct number of the applicable ID and LAH settings that had sufficiently remediated to overcome the presumption that they were institutional in nature as of July 1, 2021, was zero (0), while the correct number of settings that had not yet overcome the presumption that they were institutional in nature was 1,041.

The listing attached to this public comment request includes all of those 1,041 settings that continue to provide waiver services as of June 26, 2023. This number of settings subject to the State's Statewide Transition Plan (Alabama Statewide Transition Plan) has been reduced to 726 (669 residential settings and 57 non-residential settings), due to voluntary program closures as well as some findings of noncompliance with the mandatory HCBS Settings Rule requirements pursuant to the guidance of the CMS Recalibrated Strategy.

As the CMS Recalibrated Strategy allows, the State has submitted a request for a Corrective Action Plan (CAP) on behalf of ADMH-DDD for the ID and LAH Waivers that will allow additional time to come into full compliance with certain Final Rule requirements that have been impacted by the COVID-19 Public Health Emergency (PHE), including several that affect remedial efforts related to isolating characteristics. These include access to the broader community; opportunities for employment; an option for a private residential unit and/or choice of a roommate; and the choice of non-disability specific settings. The CAP request identifies December 1, 2023, as the final date for HCBS settings to fully remediate, including the elimination of any isolating characteristics. Between now and December 1, 2023, upon the achievement and validation by ADMH-DDD of remediation that overcomes this institutional presumption, each setting will be subject to additional public review and comment.

Residential Settings that had not sufficiently remediated to overcome the presumption of being institutional in nature due to isolating characteristics as of July 1, 2021.
