

## ALABAMA HOME AND COMMUNITY-BASED SERVICES (HCBS) WAIVERS

Medicaid is a health care program for low income Alabamians. Home and Community-Based Waiver services provide additional Medicaid benefits to specific populations who meet special eligibility criteria. This chart summarizes those benefits, criteria, and informs you on how to apply for a HCBS waiver. Applicants must meet financial, medical, and program criteria to access waiver services. The applicant also must be at risk of nursing institutionalization (nursing facility, hospital, ICF/IID). A client who receives services through a waiver program also is eligible for all basic Medicaid covered services. Each waiver program has an enrollment limit. There may be a waiting period for any particular waiver. Applicants may apply for more than one waiver, but may only receive services through one waiver at a time. Anyone who is denied Medicaid eligibility for any reason has a right to appeal.
